

### **APPLICATION**

Institutional Membership in AAN is open to Alumni Associations and entities of Higher Education significantly engaged in graduate of doctoral studies and post-graduate education, research, and scholarship. Institutional Membership will belong to the association, entity, or company and not the individual who represents the association.

Institutional Membership is 12 months (January 1 – December 31). Institutional Membership include a representatives of each entity having access to **AAN's Institutional Members Only** and posting the following:

- Research Topics in the Group section under the Predetermined Categories
- Virtual Positions in the Classified section under the Predetermined Headings
- Events in the Event section

Institutional Membership also includes submitting "Call for Papers" information (maximum 2 lines per posting) quarterly to be included on the home page of AAN's website in the **IN-Blog** section for a duration of one (1) month per posting.

No prorated fees will be accepted. Renewal fee will be \$1,500.00 USD for each entity regardless of size each succeeding year unless otherwise changed by AAN's officers.
